VOLUNTEERS CARE FOR AND MANAGE THESE PUBLIC SPACES AS IF THEY WERE THEIR OWN GARDENS. IN 2017, COMMUNITY VOLUNTEERS PROVIDED 6,617 HOURS OF SERVICE.
